In the said Scheme,

(1) in clause 2, the sub-clause (B) shall be substituted by the following :-

“Eligible persons shall submit Application (as per enclosed Format – Annexure-A) to the local police authority in Kolkata Municipal Corporation Area. However in other Urban Local Bodies eligible persons shall submit Application (as per enclosed Format – Annexure-A) to the local police authority through the Office of the District Magistrate/ the Sub-divisional Officer/ Urban Local Body concerned.”
