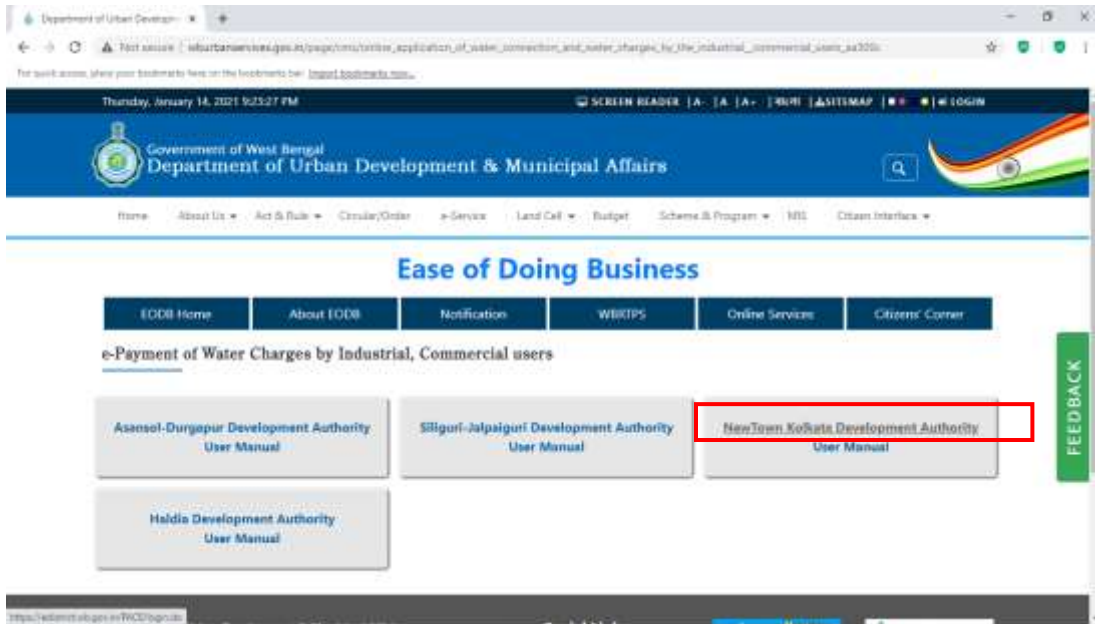

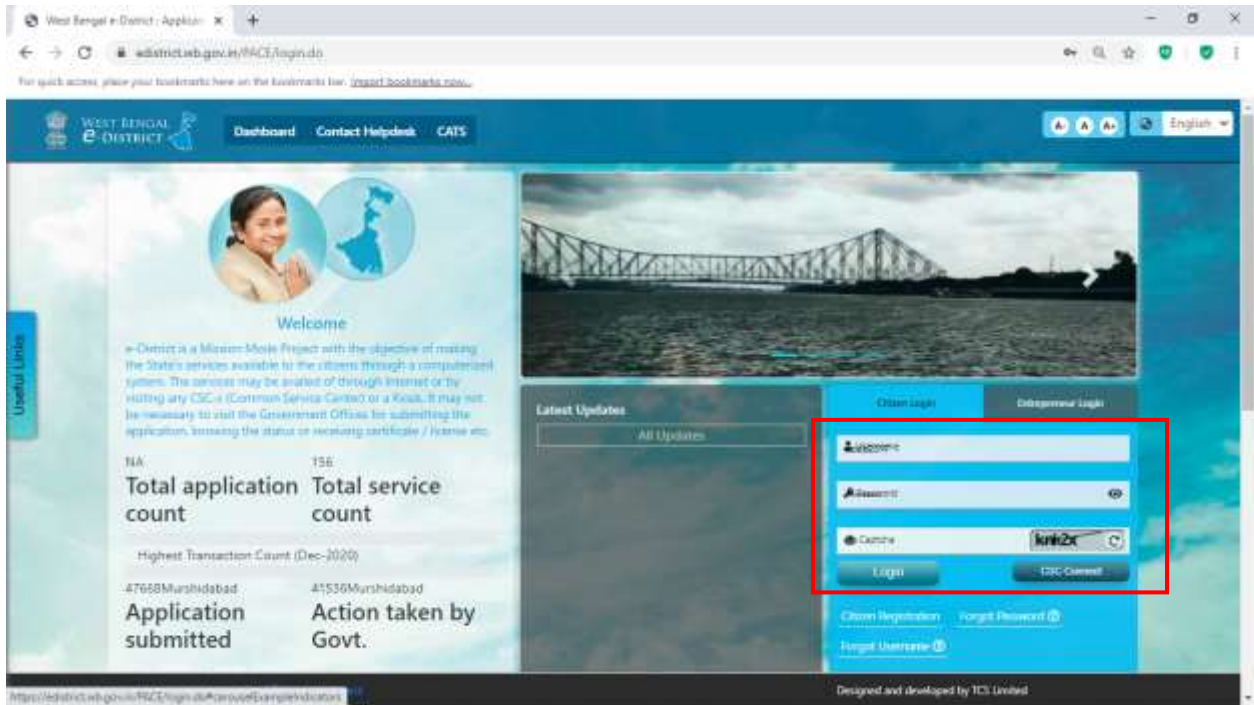

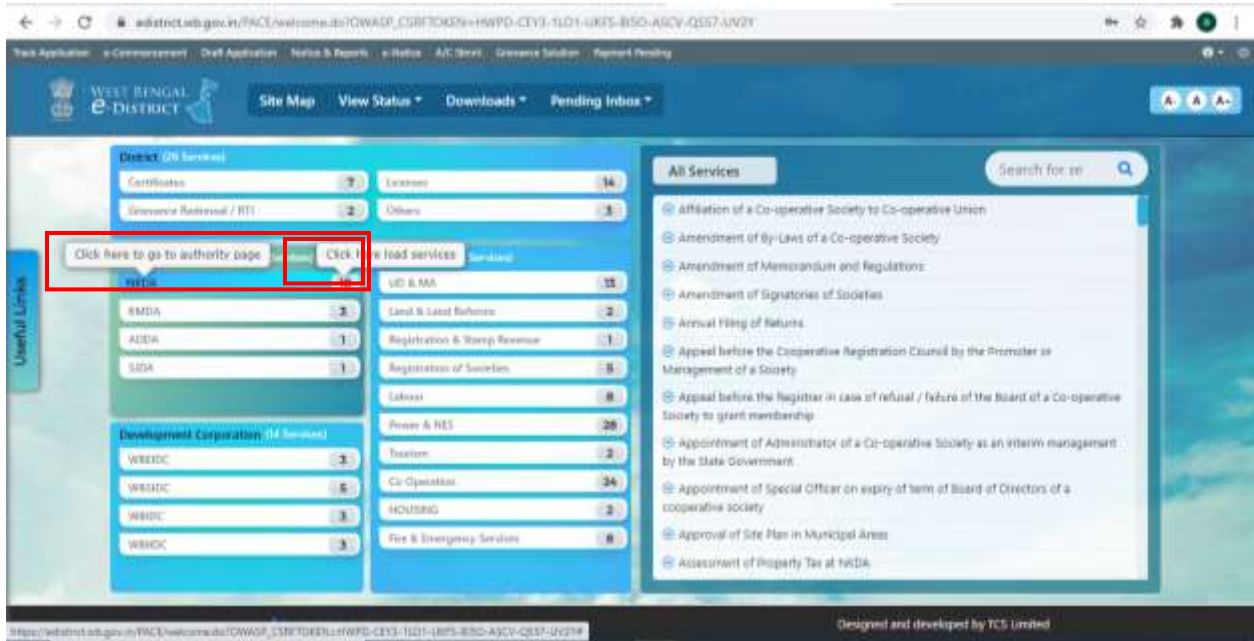

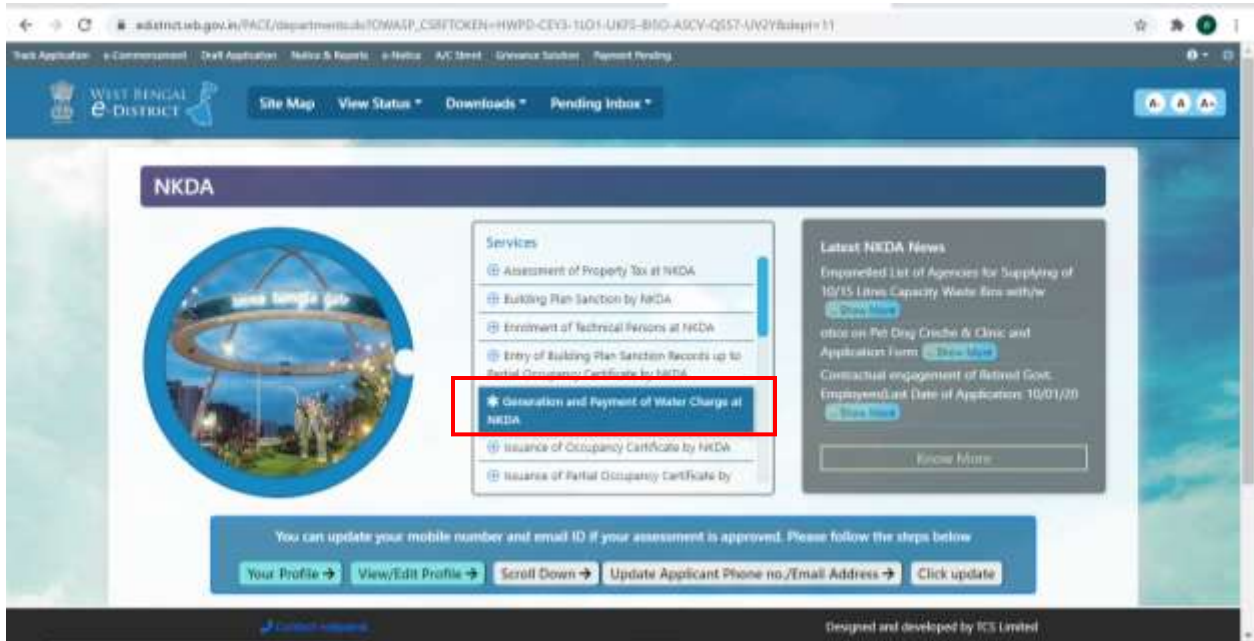

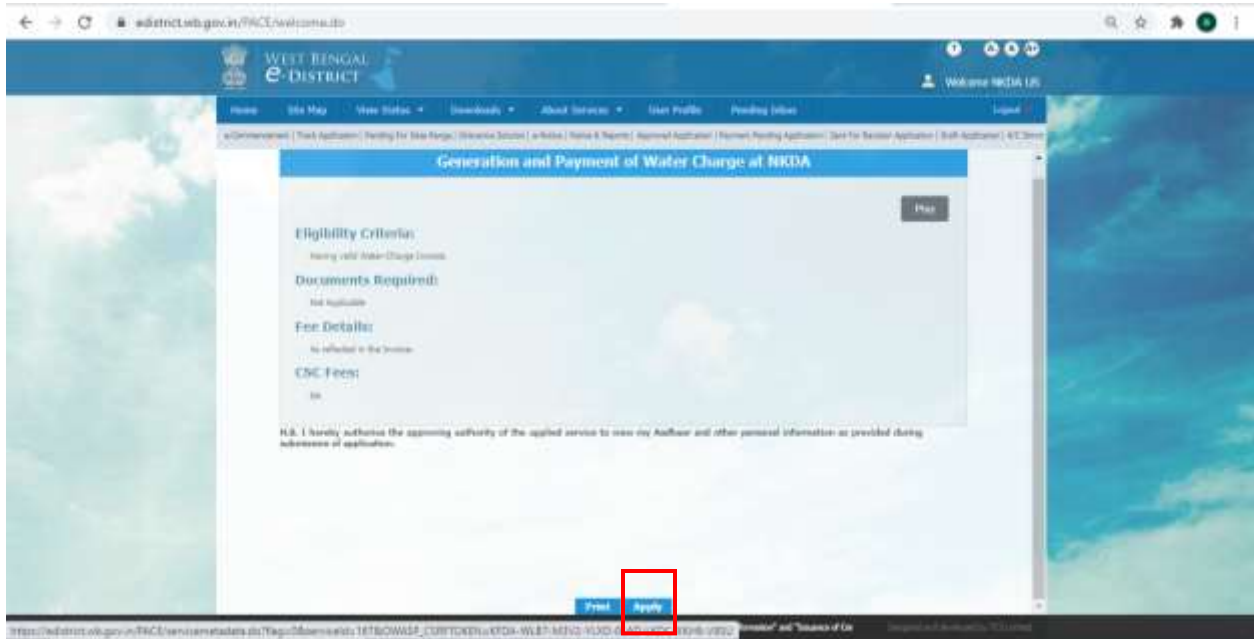

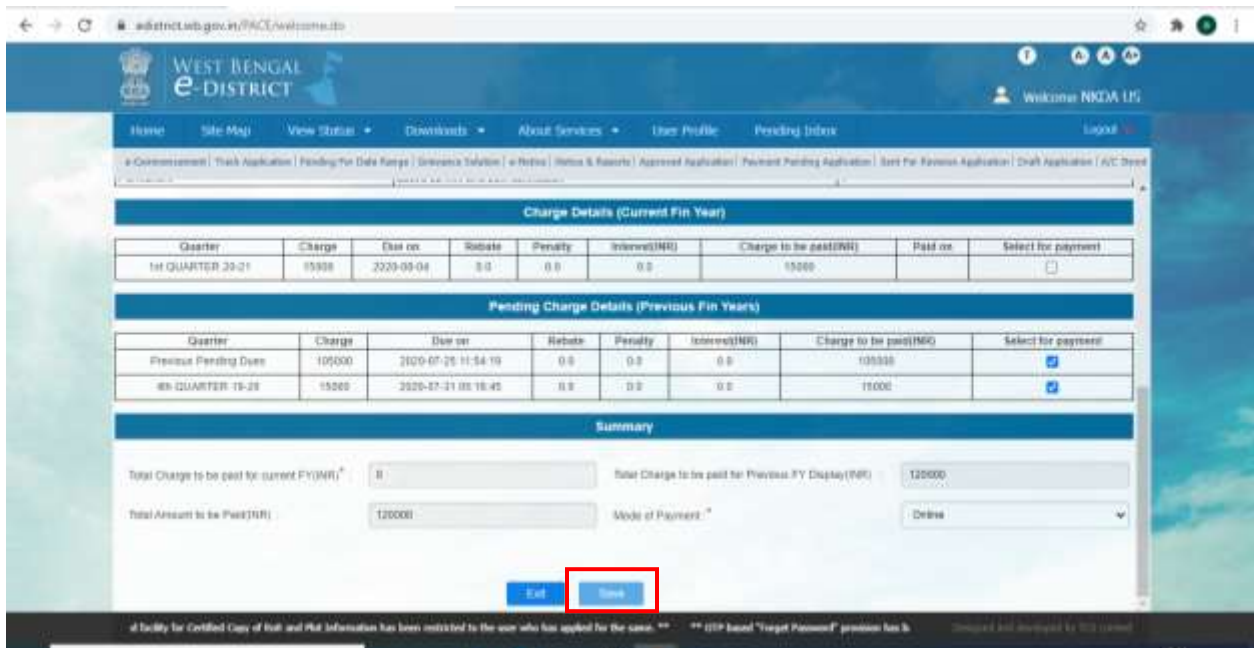

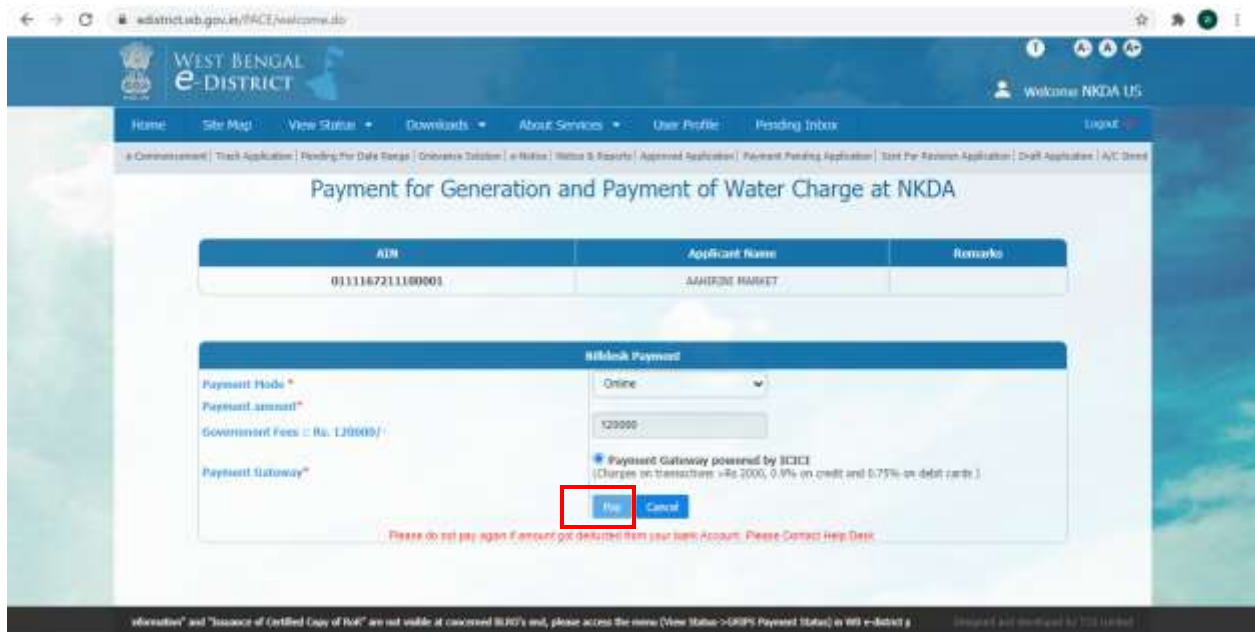

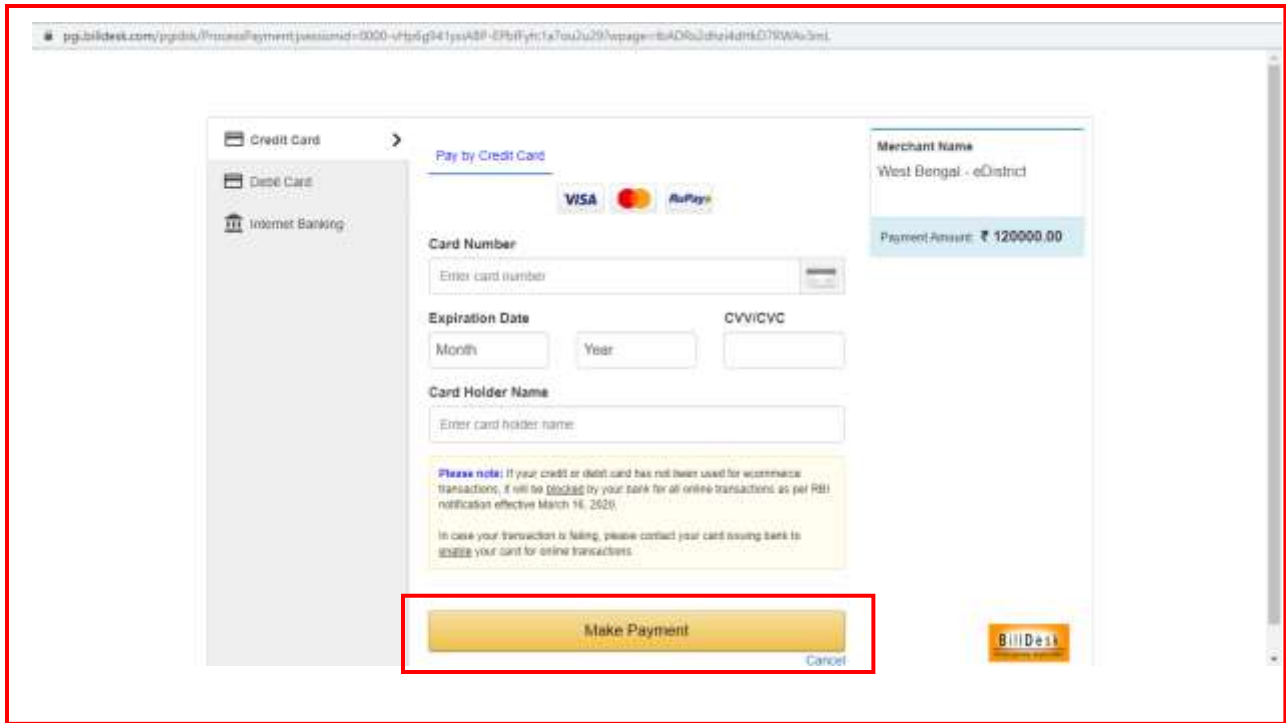

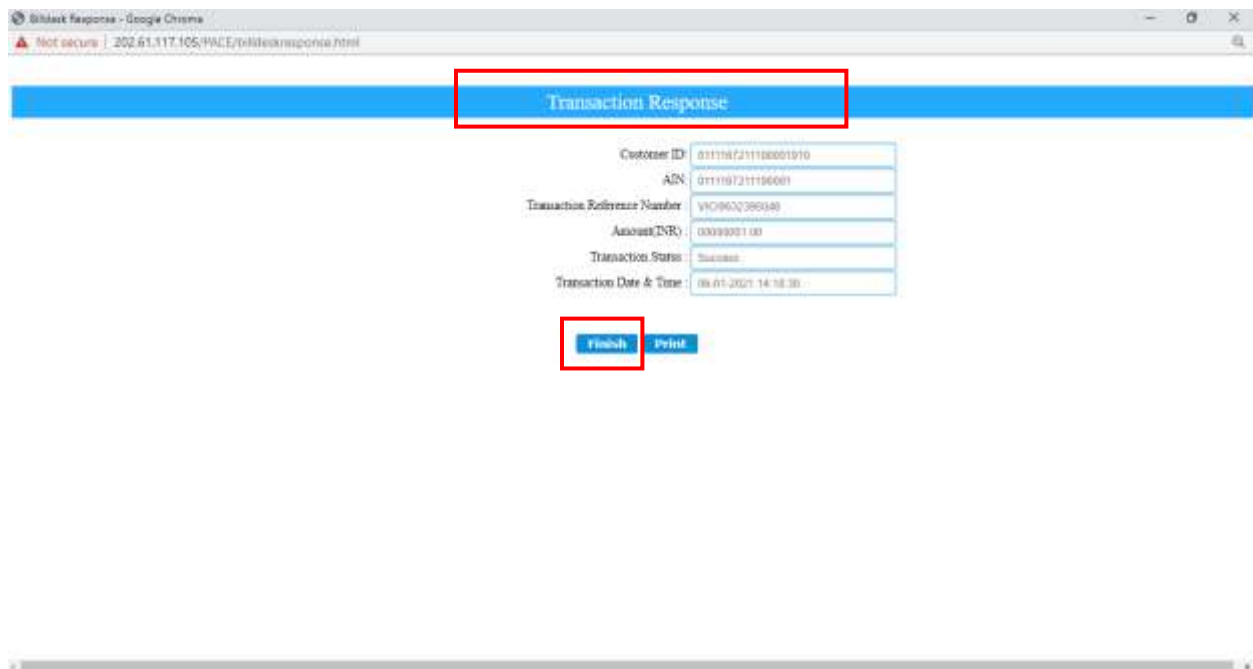

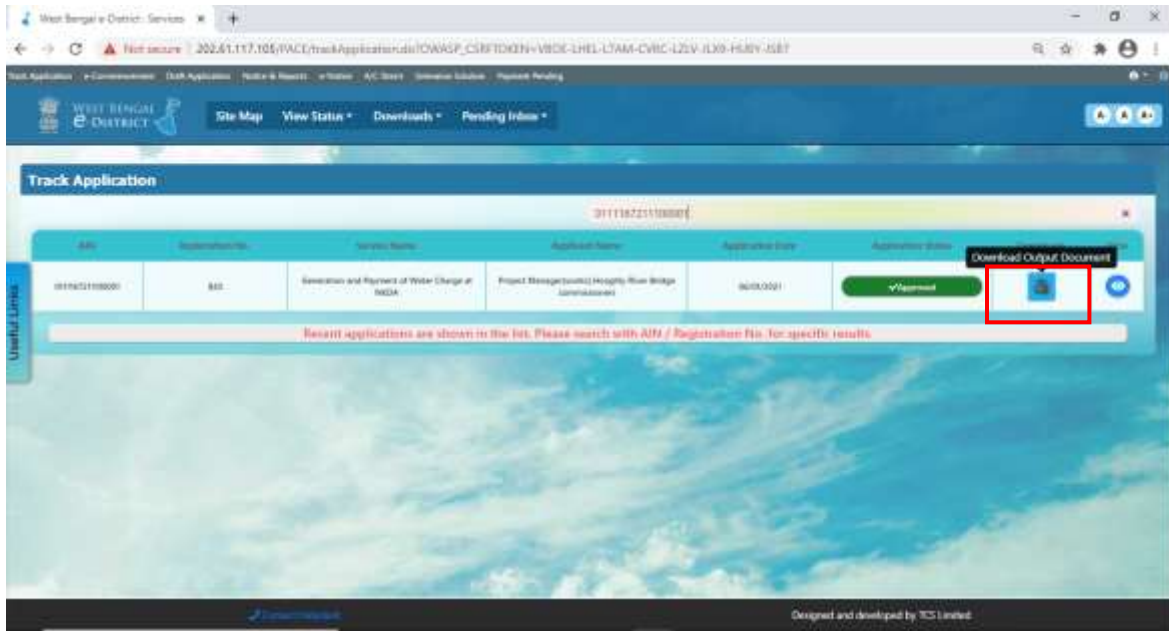


Track Application Option for Application under Applicant Login
