In accordance with the directions given by Hon'ble National Green Tribunal in different cases, regarding violation of environmental laws and rules and fixing up of accountability of the erring officers attached in the pollution abatement programme, it is hereby directed that the officers and engineers of this Department or Directorate/Parastatals/Statutory Bodies under this Department who are engaged in the programme for management of Solid Waste/ Liquid Waste/ Legacy Waste/ Air and Sound pollution, would mandatorily mention in their annual SAR:

1. The targets fixed up towards abatement of pollution and progress achieved against that target.
2. Shortfall if any in achieving targets and reasons of shortfall.

Quantitative and qualitative assessment against submission of SAR would be made accordingly by the respective Reporting/Reviewing Officers.

The authorities in this Department or Directorate/Parastatals/Statutory Bodies under this Department would be responsible for implementation of this order under their jurisdiction.

This will take immediate effect.
