NOTIFICATION

No. 110/MA/O/C-4/IM-11/2000, Dated, Kolkata, the 26th day of February, 2016 :— WHEREAS it appears to the Governor that Tehatta in the district of Nadia (hereinafter referred to as the said town)—

- (1) contains a population of 45,748 which is not less than 30,000 inhabitants;
- (2) has a density of population of 1118.75 per square kilometre which is not less than seven hundred and fifty inhabitants per square kilometre of area; and
- (3) has an occupational pattern of 62 % which is more than one half of the adult population who are chiefly engaged in pursuits other than agriculture;

AND WHEREAS the Governor is satisfied that if the said town with a proposed area of 40.892 sq. Km. is constituted a municipal area, the municipal income from taxation and other sources is likely to be adequate for the discharge of the municipal function under the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) (hereinafter referred to as the said Act);

NOW, THEREFORE, in exercise of the power conferred by section 3 of the said Act, the Governor in supersession of earlier notification on this subject, is pleased hereby to declare his intention to constitute the said town consisting of the land the description of which has been specified in the schedule below, a municipal area, namely 'Tehatta Municipal area' in the district of Nadia;
