**ORDER**

**Dated, Kolkata, the 2<sup>nd</sup> September, 2021**

WHEREAS the Golden City Industrial Township has been constituted at Bengal Aerotropolis Private Limited Project Area at Andal in the district of Paschim Bardhaman vide this Department's Notification No. 221/MA/O/C-4/1M-40/2014, dated the 24<sup>th</sup> April, 2015 in terms of provisions of sub-section (3) of section 385A of the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) (hereinafter referred to as the said Act) and a notification has also been issued vide this Department's Notification No.286/MA/O/C-4/1M-40/2014, dated the 20<sup>th</sup> May, 2015 extending the provisions of the said Act to the Golden City Industrial Township in terms of provisions of clause (a) of sub-section (1) of section 385B of the said Act;

AND WHEREAS the District Magistrate, Paschim Bardhaman and Chairman, Golden City Industrial Township Authority has informed this Department vide letter No. 146/IV-2/C, dated 26.08.2021 that several applications for sanction of building plans regarding various projects which have been set up and/ or are proposed to be set up within the jurisdiction of Golden City Industrial Township Authority are lying pending for disposal because of severe shortage of manpower;

AND WHEREAS on behalf of the Golden City Industrial Township Authority, the District Magistrate, Paschim Bardhaman and Chairman, Golden City Industrial Township Authority has proposed to transfer the function of Golden City Industrial Township Authority related to sanction of building plans regarding various projects which have been set up and/ or are proposed to be set up within the jurisdiction of Golden City Industrial Township Authority to the West Bengal Industrial Development Corporation (WBIDC) in terms of provision of section 66 of the said Act in order to expeditious disposal of building plans;

AND WHEREAS in terms of provisions of section 66 of the said Act, approval of the State Government is required to be accorded to the proposal for transferring any function or functions of the Municipality under the said Act to any individual or organization, in such manner, and on such terms and conditions, as may be determined by the Board of Councillors in the public interest or for the purpose of carrying out the provisions of the said Act;

NOW THEREFORE in exercise of the powers conferred by section 66 of the said Act, the Governor is pleased hereby to accord approval to the proposal of the District Magistrate, Paschim Bardhaman and Chairman, Golden City Industrial Township Authority for transferring the function of Golden City Industrial Township Authority related to sanction of building plans regarding various projects which have been set up and/ or are proposed to be set up within the jurisdiction of Golden City Industrial Township Authority to the West Bengal Industrial Development Corporation (WBIDC) in the public interest.
