The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction and release payment of a sum of Rs. 2,73,88,620/- (Rupees two crore seventy three lakhs eighty eight thousand six hundred twenty) only to the Howrah Municipal Corporation as grants on adhoc basis towards residual payment of 40% of total requirement (Basic Pension + Dearness Relief) of pension on the revised scale of pay to the pensioners of Howrah municipal Corporation as communicated vide their letter no. AC/Per/10/1/13-14 dated 05.04.2013 for the year 2011-12 during this financial year i.e. 2013-14.

2. The Grant-in-aid sanctioned herein above will be drawn by the Commissioner, Howrah Municipal Corporation in T.R. Form No. 48 after it is duly countersigned by the District Magistrate, Howrah.
3. The charge is debitable to the head, "2071-Pensions and other Retirement Benefits-01-Civil-110-Pension of Employees of Local Bodies-NP-Non-Plan-001-Provision for payment of pension of Employees of Local Bodies-04-Pension/Gratuities-V" under Demand No. 18/Finance (Audit) in the current year's budget i.e. 2013-2014.
4. Utilization Certificate is to be furnished by the Howrah Municipal Corporation in the prescribed form directly to the Principal Accountant General (A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilized.
5. This order issues in exercise of the powers delegated under Finance Department Memo No. 622-FB dated 01.08.2013.
