ORDER

As per the notification issued by the State Government, the Urban Development Department and Municipal Affairs Department merged in December, 2016. The Municipal Affairs Department earlier located at Poura Bhavan shifted to the Nagarayan Building where the Urban Development Department was already located. Over a period of time the different divisions of the 2 (two) Departments were merged as a single entity. However the Establishment Section of both the Departments continued to exist as UD & MA Establishment. Therefore for the optimal and the best deployment and services of the HR posted at this Department at all levels of both the establishments need to be merged.

In supersession of all previous orders it has been decided to merge both the establishments and have a unified establishment of the UD & MA Department.
