NOTIFICATION

No. 383/UDMA-15011(17)/2/2023-LS-MA SEC, dated, Kolkata, the 23rd May, 2023.— In exercise of the power conferred by section 601 of the Kolkata Municipal Corporation Act, 1980 (West Ben. Act LIX of 1980) (hereinafter referred to as the said Act), the Governor, is pleased hereby to amend the Schedule VI of the said Act in the following manner :

Amendments

In Schedule VI of the said Act—

1. omit the words "or six months' imprisonment or both" under column (3), against the entry "Section 417, sub-section (5)" under column (1)";
2. for the words "Five thousand rupees or six months' imprisonment or both" under column (3), against the entry "Section 419, sub-section (1)" under column (1), substitute the words "Ten thousand rupees";
3. for the words "Five thousand rupees or six months' imprisonment or both" under column (3), against the entry "Section 420, sub-section (1)" under column (1), substitute the words "Ten thousand rupees";
4. for the words "Two thousand and five hundred rupees or six months' imprisonment or both" under column (3), against the entry "Section 421, sub-section (1)" under column (1), substitute the words "Ten thousand rupees";
5. omit the words "or six months' imprisonment or both" under column (3), against the entry "Section 423, sub-section (1)" under column (1)";

6. for the words "Five thousand rupees or six months' imprisonment or both" under column (3) against the entry "Section 428, sub-section (1)" under column (1), substitute the words "Ten thousand rupees";
7. for the words "Five thousand rupees or six months' imprisonment or both" under column (3), against the entry "Section 428, sub-section (3)" under column (1), substitute the words "Ten thousand rupees";
8. omit the words "or six months' imprisonment or both" under column (3), against the entry "Section 435, sub-section (1)" under column (1)";
9. omit the words "or six months' imprisonment or both" under column (3), against the entry "Section 437, sub-section (1)" under column (1)";
