Sub: Payment of grants to the Urban Local Bodies on Account of 'Pension' for the Municipal Pensioners at the revised rate during the year 2013-2014.

The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment of a sum of Rs. 3,74,89,826/- (Rupees Three crore seventy four lakh eighty nine thousand eight hundred twenty six) only to the Urban Local Bodies on adhoc basis towards payment of 40% of total requirement (Basic Pension + Dearness Relief) of pension on the revised scale of pay to the pensioners of the Urban Local Bodies for the year 2009-2010, 2010-2011, 2011-2012 and 2012-2013 as specified in the 'Remark' column of the enclosed statement during this financial year i.e. 2013-2014.

2. The District Magistrate concerned is hereby authorised to draw the grants sanctioned above and disburse the same to the Urban Local Bodies concerned by transfer credit through Local Fund Account of the concerned Urban Local Bodies in favour of the pensioners who have received the P.P.O. for drawal of their pension.

3. The charge is debitible to the head, "2071-Pensions and other Retirement Benefits-01-Civil-110-Pension of Employees of Local Bodies-NP-Non-Plan-001-Provision for payment of pension of Employees of Local Bodies-04-Pension/Gratuities-V" under Demand No. 18/Finance (Audit) in the current year's budget i.e. 2013-2014.

4. Utilization Certificate is to be furnished in the prescribed form directly to the Principal Accountant General (A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilized.

5. This order issues in exercise of the powers delegated under Finance Department memo no. 622-FB dt. 01.08.2013.

6. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
