NOTIFICATION

No. 560/MA/O/C-4/1M-13/2009(Part-I)

Dated, Kolkata, the 18th day of August, 2015.

WHEREAS in the opinion of the Governor, it is necessary to constitute an industrial township under section 385A of the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) (hereinafter referred to as the said Act), comprising areas in and around Calcutta Leather Complex in the district of South 24 Parganas, specified in the Schedule below (hereinafter referred to as the said areas) for the purpose of making provisions of all or any of the provision of the said Act, in respect of the said areas where the industries have been or are being established;

AND WHEREAS by this Department notification No. 01/MA/O/C-4/1M-13/2009(Part-I), dated the 2nd January, 2015, published in the *Kolkata Gazette Extraordinary*, dated the 5th January, 2015 (hereinafter referred to as the said notification), the Governor has been pleased to declare his intention to constitute the said areas, consisting of the land as described in the Schedule below, an industrial township under sub-section (1) of section 385A of the said Act;

AND WHEREAS the period of three months from the date of publication of the said notification, for submitting objection or suggestion has expired and two objection petitions were received in Municipal Affairs Department, Government of West Bengal during the period aforesaid;

AND WHEREAS the objection petitions were sent to District Magistrate, South 24 Parganas with a request for arrangement to give the petitioners the opportunity of being heard and to send a consolidated report thereof along with his views in this regard to Municipal Affairs Department, and after hearing, District Magistrate, South 24 Parganas has proposed to constitute the said areas an Industrial Township, consisting of the land as described in the Schedule below;

NOW, THEREFORE, in exercise of the power conferred by sub-section (3) of section 385A of the said Act, the Governor is pleased hereby to constitute an industrial township namely "Sector VI" in the district of South 24 Parganas comprising the said areas more fully described in the Schedule below :—
