NOTIFICATION

No. 565/MA/O/C-4/IM-5/2017, dated Kolkata, the 8th August, 2018 – WHEREAS the Governor expressed his intention vide notification No. 677/MA/O/C-4/IM-5/2017, dated 23rd day of October, 2017, published in Kolkata Gazette Extraordinary on 23rd day of October, 2017 (hereinafter referred to as the said notification) for inclusion of four contiguous mouzas of Balurghat Municipality, constituted under the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) (hereinafter referred to as the said Act), namely Chakvrigu (Full), Dakra(part), Belain (part) and Gobindapur (part) under Chakvrigu Gram Panchayat, constituted under the West Bengal Panchayat Act, 1973 (West Ben. Act XLI of 1973) (hereinafter referred to as the said areas) within the jurisdiction of the Balurghat Municipality in the district of Dakshin Dinajpur consisting of the land as described in the Schedule below under clause (c) of section 9 of the said Act;

AND WHEREAS the period of thirty days from the date of publication of the said notification in the *Kolkata Gazette*, for submitting objection in respect to the said notification by the inhabitant of the said areas in writing to the State Government has expired and some objection petitions were received in Urban Development and Municipal Affairs Department, Government of West Bengal from the inhabitants of the said areas during the period aforesaid;

AND WHEREAS the objection petitions were sent to District Magistrate, Dakshin Dinajpur with a request for arrangement to give the petitioners the opportunity of being heard and to send a consolidated report thereof along with his views in this regard to Urban Development and Municipal Affairs Department and after hearing District Magistrate, Dakshin Dinajpur has proposed to include the said areas within the jurisdiction of Balurghat Municipality in the district of Dakshin Dinajpur consisting of the land as described in the Schedule below;

NOW, THEREFORE, in exercise of the power conferred by clause (c) section 9 of the said Act, the Governor is pleased hereby to include the said areas, consisting of the land as specified in the Schedule below, within the jurisdiction of Balurghat Municipality in the district of Dakshin Dinajpur: –
