In continuation to G.O. No.292G(2)/MA/N/C-2/1G-3/2010 dated 18.02.2011, the undersigned is directed, by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs.6,76,26,800/- (Rupees Six crore seventy six lakh twenty six thousand and eight hundred) only for payment of the existing honorarium of Siksha Sahayikas and Academic Supervisors as per G.O. No.115/MA/C-10/3S-33/2010 dated 18.02.2011; along with payment of contingencies for the period from April,2011 to July,2011 to the Director of Local Bodies, West Bengal for smooth running of Sishu Shiksha Kendras within the Urban Local Bodies during 2011-2012.

2. The amount sanctioned in Para-I above amounting to Rs.6,76,26,800/- is to be monitored and sub-allotted from the level of Director of Local Bodies, West Bengal in favour of the Urban Local Bodies and the District Magistrate of the concerned districts will act as the D.D.O. for drawal by transfer credit to the L.F. Account of respective Urban Local Bodies.

The charge is debitable to the Head, "3604-Compensation & Assignments to Local Bodies and Panchayati Raj Institutions-00-200-Other Miscellaneous Compensation & Assignments-NP-Non-Plan-034-Fixed Grants to Municipal Corporations and other Urban Local Bodies-31-Grants-in-aid-GENERAL-02-Other Grants-V" under Demand No.39/MA in the current year's vote-on-account budget i.e. 2011-12.

4. The Utilisation Certificate is to be furnished by the Director of Local Bodies, West Bengal in terms of Note-2 below S.R. 330A of the Treasury Rules, West Bengal, Volume-I directly to the Principal Accountant General(A&E), West Bengal with a copy to this Department.
