**ORDER**

No. 716/UDMA-15011(24)/14/2022-LS-MA SEC

Dated, Kolkata, the 7<sup>th</sup> July, 2022


WHEREAS in terms of provisions of section 127 of the West Bengal Municipal Corporation Act, 2006 (West Ben. Act XXXIX of 2006) (hereinafter referred to as the said Act), the Corporation may, for reasons to be recorded in writing, at any time direct alteration or amendment of the assessment list and in terms of provision of section 128 of the said Act, the Corporation may, at any time, cause the annual valuation of such holding and make assessment thereon and after finalization, may make addition of such valuation and addition to the assessment list is made when a new building has been constructed or a new holding has been created by mutation or by transfer or upon the inclusion of any local area within the Corporation or otherwise during the period an assessment list remains in force and in case of transfer or devolution of land and building, the Corporation shall record the transfer or devolution of property in terms of provisions of section 131 of the said Act;

AND WHEREAS the Corporation may, with a view to determine the annual value of any holding, issue a notice to the owner or occupier in terms of sub-section (1) of section 130 of the said Act and the owner or occupier shall be bound to comply with such notice and to furnish a return in terms of sub-section (3) of section 130 of the said Act. In terms of sub-section (4) of section 130 of the said Act, the Commissioner or any person subordinate to him and authorized by him in writing in this behalf, may make an inspection or survey and take measurement of such land or building and verify the statement made in the return submitted sub-section (3) of section 130 of the said Act;

AND WHEREAS the power to conduct inspection for the purpose of section 130 of the said Act can be exercised by the Corporation for those returns in respect of which the Corporation feels it expedient to verify the statement made in such returns filed for determination of annual valuation of any holding. This is not a concurrent action for the applications or notices received for alteration and amendment of the assessment list under section 127 or addition to the assessment list under section 128 or mutation or transfer of title done under section 131 of the Act, as the case may be;

NOW THEREFORE considering above, the Governor is pleased hereby to clarify that in terms of provisions of sub-section (4) of section 130 of the said Act, inspection or survey and taking measurement of land and building to verify the statement made in any return for determination of annual valuation of any holding, is done if the Corporation feels it expedient to do so but it has no linkage with such cases submitted for the purpose of alteration and amendment of the assessment list under section 127 or addition to the assessment list under section 128 or mutation or transfer of title made under section 131 of the Act, as the case may be.

This has been issued to comply with the requirement of Ease of Doing Business to elucidate that the process of inspection by Corporation is not a prerequisite formality for the purpose of addition or alteration or amendment of assessment list or mutation of property or transfer of title etc., as the case may be.
