NOTIFICATION

In exercise of the power conferred by Section 141 of the West Bengal Municipal Corporation Act 2006 (West Ben. Act XXXIX of 2006), the Governor is pleased hereby to make the following amendments in the Guidelines in relation to enlistment of Profession, Trade and Calling in the Municipal Corporations issued under this Department's order no. 570/MA/O/C-4/3R-4/2015 dated , Kolkata, the 19th day of August,2015(hereinafter referred to as the said Guidelines) read with order No. 807/MA/O/C-4/3R-4/2015 dated , the 26th August, 2019 and read with order no. 1031/MA/O/C-4/2015 (Pt.-IV), dated the 30th November,2020, with immediate effect :-

Amendments

In the said Guidelines,

1. After sub-clause (3) of Clause 6, the following proviso shall be inserted :-

"Provided that the Municipal Corporations will give 5% rebate on total amount to be payable by the applicant as charges for municipal services for multiple years while granting renewal for extended periodicity.";

2. For sub-clause (7) of Clause 6, the following sub-clause shall be substituted :-

"(7) The Certificate, if not renewed in due time, shall be deemed to be lapsed/expired . However, after the due date certificate can be renewed online upon online application subject to up-to-date online payment with all arrears including late fines . For default in renewal upto five years from the due date, the late fines will be 1.25 times of the application fees. For default in renewal for more than five years and upto ten years from the due date, the late fines will be 1.5 times of the application fees. For default in renewal for more than ten years from the due date, the late fines will be 2 times of the application fees."
