WHEREAS in exercise of the power conferred by sub-section (3) of section 9 of the said Act, the Governor is hereby pleased to sub-divide Bakreswar Planning Area (original) of Bakreswar Planning Authority and include the sub-divided area described in Schedule II in Bakreswar Planning Area (revised), as mentioned hereafter.

AND WHEREAS, in exercise of the power conferred by sub-section (3) of section 9 of the said Act, the Governor is hereby pleased to sub-divide Bakreswar Planning Area original of Bakreswar Planning Authority and include the sub-divided area described in Schedule II in Bakreswar Planning Area (revised) of Bakreswar Development Authority and whereas in exercise of the power conferred by sub-section (1), read with sub-section (2) of section 9 of the said Act, the Governor is pleased hereby to declare the area as mentioned in the Schedule I & Schedule II to this Department's Notification No. 938-T&CP/C-2/1P-05/2016 dated the 1st June, 2016 as the Bakreswar Planning Area (revised) of Bakreswar Development Authority for the purpose of the said Act.
