**NOTIFICATION**

Whereas, an offer was made to M/s. AMRI Hospitals Ltd. by WBHIDCO Ltd. for allotment of 5(five) acres of land comprised in plot No. DG-19 within AA-1D, New Town, Kolkata for the purpose of setting up a Multi-Speciality / Super-Speciality Hospital on 3 (three) acres of land and for the purpose of setting up a Nursing College with Hostel facility and Para-Medical College exclusively on the balance 2 (two) acres of land out of the total quantum of land;

And whereas, subsequently on request from M/s. AMRI Hospitals Ltd. the above plot was bifurcated and assigned numbers DG-19 and DG-19/1 having areas 3(three) and 2(two) acres respectively for the purpose of setting up a Multi-Speciality / Super-Speciality Hospital under principal use 'Institutional' on the former plot of land and for the purpose of setting up a Nursing College with Hostel facility and Para-Medical College under principal use 'Educational' on the latter plot of land;

And whereas, M/s. AMRI Hospitals Ltd. has now given a representation to the State Government seeking for amalgamation of these two bifurcated plots to facilitate better synergy between the proposed Hospital and the Nursing and Para-Medical college and optimum utilisation of the total quantum of land;

And whereas, after careful consideration of the representation from M/s. AMRI Hospitals Ltd. seeking for amalgamation of the plots, the Governor is satisfied that it would be in the public interest so to do;

Now, therefore, in exercise of power conferred by sub-section (3) of section 65 of the New Town Kolkata Development Authority Act, 2007 (West Bengal Act XXX of 2007) the Governor is pleased hereby to amalgamate Plot No.s DG-19 and DG-19/1 in New Town, Kolkata for construction of Multi-speciality / Super-speciality Hospital alongwith Nursing College with Hostel facility and Para-medical College thereon by the allottee of the Plots i.e. M/s. AMRI Hospitals Ltd. subject to the following conditions:

**CONDITIONS:**

1. 25 beds of the Hospital shall be kept in a separate enclosure as free beds reserved for WBHIDCO Ltd.. Poor and needy patients shall be admitted to these specific beds on recommendation of WBHIDCO Ltd. and shall be given same quality of treatment. Upto 50% of the total cost of investigation, tests, pathology tests and attendant charges etc. shall be charged on the patients of these free beds.
2. 15% of the total seats of the Nursing and Para-medical College shall be kept reserved for the meritorious students which will be filled up on recommendation from the State Government on the basis of the common entrance examination held for admission in Nursing Colleges conducted by the State Govt and the common entrance procedure held for admission in paramedical courses.

This issues in cancellation of this Department's earlier Notification No.612-UD/O/M/HID/5M-01/2015 dated 26th February, 2015 and with the approval of the Standing Committee of the Cabinet on Industry, Infrastructure and Employment in its 45th meeting held on 07-05-2015.
